

I am directed to state that the Postgraduate Medical Education Committee of this Council at its meeting held on 09/05/2017 considered the Compliance Verification Assessment Report (09/03/2017) along with the Council Assessor's Report (July, 2016) and compliance dated 31/12/2016 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD(Pulmonary Medicine/TB & Respiratory Medicine) qualification for 1 seat at Amala Institute of Medical Sciences, Thrissur granted by Kerala University of Health Sciences, Thrissur/ Kerala University and decided as under:-

"The Postgraduate Medical Education Committee considered the compliance Verification Assessment Report (09/03/2017) along with the Council Assessor's Report (July, 2016) and compliance dated 31/12/2016 submitted by the college authorities and decided to recommend to the Central Government that MD(Pulmonary Medicine/TB & Respiratory Medicine) qualification for 1 seat granted by Kerala University of Health Sciences, Thrissur/ Kerala University in respect of students being trained at Amala Institute of Medical Sciences, Thrissur be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."
