Based on the reply furnished by the college/institute, approval of the PGMEB is hereby accorded in terms of Section 25(i) and 35(4) of NMC Act, 2019, for grant of **Renewal of Recognition of MS(Obstetrics & Gynaecology) qualification for 02 seats in respect of students being trained at Amala Institute of Medical Sciences, Thrissur under Kerala University of Health Sciences, Thrissur**, under the following terms and conditions, as contained in the Post Graduate Medical Education Regulations, 2000:






